Certain Definitions:

"Content" shall mean all content featured or displayed through the myQNX Site, including without limitation information, code, documentation, text, data, articles, images, photographs, graphics, software, applications, packages, designs, and other content or materials that are available on the myQNX Site as part of delivery of or use of the services provided in connection with the myQNX Site. The definition of "Content" specifically includes BlackBerry Content, User-Generated Content (including Your Content) as these terms are defined herein. "BlackBerry Content" shall mean BlackBerry generated Content made available by BlackBerry or its personnel through the myQNX Site and may include BlackBerry Licensed Software. - (ii) Jarvis Software Licensing Terms. If You have obtained a license to BlackBerry Jarvis Software, then, notwithstanding anything else stated herein, unless otherwise agreed in a signed agreement, You hereby agree and confirm that Your use of the Jarvis Software (including any technical support services and any updates obtained through technical support and maintenance) is subject to the terms and conditions of the relevant BlackBerry Solution License Agreement ("BlackBerry Solution License Agreement" or "BBSLA"). - b. Professional Services. If You have purchased BlackBerry professional services then, unless otherwise agreed in a signed agreement, the terms and conditions of the Professional Services Agreement and any addendums thereto and the applicable Services Program Description each which may be found at https://www.blackberry.com/us/en/legal shall apply. If You or the entity for whose benefit You are authorized to obtain Professional Services on behalf of have executed a signed version of the applicable Professional Services Agreement, then notwithstanding anything else herein, that agreement will be deemed the "Professional Services Agreement" to which You are bound. By accepting these General Terms and Conditions of Use, to the extent relevant, You hereby agree that You have read, understood, and agree to abide by and comply with the relevant Professional Services Agreement and any addendums thereto and the applicable Services Program Description and such agreement shall be incorporated by reference herein.

4. Your Responsibilities Regarding Your Use of the myQNX Site.

- a. Accuracy of the Personal Data You Provide. - e. Prohibited Uses and General Code of Conduct.
