Terms of Use / Membership Agreement

(Version 2.0)

BY ACCESSING, BROWSING OR USING THIS WEB SITE, OR BY ANSWERING “I ACCEPT” DURING YOUR MYQNX REGISTRATION, YOU REPRESENT THAT YOU HAVE READ, UNDERSTAND AND AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS TERMS OF USE / MEMBERSHIP AGREEMENT (THIS “AGREEMENT”).

The Foundry27 Web site (www.foundry27.com, or community.qnx.com) (“Foundry27”) is both a service and content portal made available by QNX Software Systems Limited and its subsidiaries and affiliates (collectively “QSS”) to the QNX developer community. All software, documentation, information and/or other materials provided on or through Foundry27 (“Content”) are for use solely under the following terms and conditions. Foundry27 may contain other proprietary notices and copyright information, the terms of which must be observed and followed.

Content

1. QSS expects the Content will change, and hopefully be improved, on a daily basis. However, the Content is the product of humans and may contain technical inaccuracies or typographical errors.
2. Registrants of Foundry27 (“Members of the QNX Community”) and QSS assume no responsibility to you regarding the accuracy of the Content. Use of the Content is at your own risk. Members of the QNX Community and QSS provide no assurances that any reported problems with any Content will be resolved. Except as otherwise expressly stated, neither Members of the QNX Community nor QSS grant any licenses to any copyrights, patents or any other intellectual property rights by providing the Content.
3. Content that is accessible using an HTML browser without becoming a Member of the QNX Community (“Open Content”) is not confidential information for the purpose of the QDLs, as defined in section 11(a) below. Source code Content that may only be accessed by Members of the QNX Community (“Accessible Content”) must be treated as confidential information of QSS and may only be used for purposes authorized by your QDL. Licenses

11. The QSS Content provided on Foundry27 site is provided:

- (a) in the case of the QNX Momentics Development Tools, QNX Neutrino RTOS and QNX Aviage Middleware software (collectively the “QNX Development Suite”), for use under the terms of one of the three following licenses (collectively the “QNX Developer Licenses”, or “QDLs”), provided that you qualify for and have received corresponding license keys from QSS, and that you have paid all applicable commercial license maintenance and/or subscription fees: (i) the free Non-Commercial End User License Agreement (“NCEULA”), (ii) the Commercial Software License Agreement (“CSLA”), or (iii) the Partner Software License Agreement (“PSLA”). Copies of these licenses are available at <http://licensing.qnx.com/> and are included in the QNX Development Suite installation media (i.e., typically in the ISO image) along with a copy of the QNX Development Suite License Guide, which provides a detailed description of the QNX Development Suite.

If you licensed earlier versions of the QNX Development Suite (e.g., under the terms of a “QNX Momentics End User License Agreement”), or if you have an alternative signed development license from QSS, then you may use QNX Development Suite Content to the extent of your entitlement under that Agreement (i.e., you may use functionally equivalent components to update your licensed software if you have paid all applicable maintenance and/or subscription fees); and

- (b) in the case of source code published by QSS under the terms of the Apache License, Version 2.0 (Apache 2.0), for use under the terms of Apache 2.0, a copy of which may be found at <http://www.apache.org/licenses/LICENSE-2.0.html>; and
 - (c) in the case of any other source or binary code Content marked with a QNX Software Systems copyright notice, or otherwise identified as proprietary code licensed by QSS (e.g., experimental, beta, trial or unsupported software), for use under the terms of a QNX Developer License, or an alternative development license from QSS to the extent of your entitlement under that Agreement.
12. Foundry27 and the QNX Development Licenses were created to encourage sharing of published Content within the QNX Community, including Content created by Members of the QNX Community. This includes distributing derivative works of runtime components of the QNX Development Suite in object code or executable form to other QNX licensees in substitution for QSS-licensed and fully paid up copies of the unmodified components, in accordance with the terms of the applicable QNX Developer License. You agree that unless you clearly post and mark your Content with notice of your alternative terms, any Content

that you upload, submit or otherwise make available to QSS or to Members of the QNX Community is provided on the following terms:

- (a) in the case of derivative works of runtime components of the QNX Development Suite, exclusively for use in substitution for a corresponding number of QSS-licensed and fully paid up copies of the unmodified runtime components, and at no additional charge: (i) for development purposes, under the license terms and restrictions of the recipient's QNX Developer License and the terms of Sections 7 and 8 of this Agreement, and (ii) for distribution purposes, under the license terms and restrictions of the QNX Runtime License Agreement published at <http://licensing.qnx.com/oem-distribution/> as of the date that the recipient's distribution begins, and the terms of Sections 7 and 8 of this Agreement; and
- (b) in the case of any modifications, enhancements and/or other code and/or documentation relating to Content licensed to you under open source license terms and conditions, under the terms of and conditions of that open source license; and
- (c) in the case of other code that extends or enhances the QNX Momentics Tools or the QNX Neutrino RTOS, under the terms of Apache 2.0.

For all other software, information and other material including, without limitation, ideas, concepts, know-how and techniques that you upload, submit or otherwise make available to QSS, Members of the QNX Community, and/or other users of Foundry27 (collectively, the "Material"), you hereby grant (or warrant that the owner of such rights has expressly granted) to QSS, Members of the QNX Community and other users of Foundry27 a worldwide, unrestricted, royalty free, fully paid up, irrevocable, perpetual, non-exclusive license to use, make, reproduce, prepare derivative works of, publicly display, publicly perform, transmit, sell, distribute, sublicense or otherwise transfer such Materials, and/or derivative works thereof, and authorize third parties to do any, some or all of the foregoing including, but not limited to, sublicensing others to do any some or all of the foregoing indefinitely.
