QNX NEUTRINO RUNTIME END USER LICENSE AGREEMENT

1. Background & Definitions.

(a) Background. QSS has developed and licenses a general purpose modular real-time operating system known as the QNXNeutrino RTOS ("Neutrino RTOS"). Its microkernel architecture provides an extensible operating system framework, which is based on the foundational components of the Platform Core technology. Additional operating system services are implemented by plugging in modules from other elements of the Neutrino RTOS (e.g., File Systems, GUI, Extended Networking, SMP, Browsers, etc.).

The Software is a subset of the Neutrino RTOS that is targeted to run on certain x86 based Reference Platforms (see definition below). It has not been tested to work with any other x86 hardware, nor has it been tested by QSS to work with any other software. It may be possible to run the QNX Neutrino RTOS on other x86 hardware platforms; however, this may require that you license the QNX Momentics^(R) Development Suite, a further software product available from QSS that allows modification and configuration of the Neutrino RTOS to run on a variety of CPUs. (b) Definitions.

- (i) "Commercially Released" means formally released, generally available and fully supported by QSS. It does not include "experimental", "engineering", "beta", "trial" or "unsupported" components.
- (ii) "Environment" means the combination of hardware platform, software environment, and Software in which you plan to use the Software.
- (iii) "License Guide" means the version of the QNX Momentics Development Suite License Guide published at <http://licensing.qnx.com/published/eula/index.html> for the Software.
- (iv) "License Key" means a license key or password from QSS that allows you to install and use the Software.
- (v) "Reference Platform" means an x86 hardware platform for which QSS has a Commercially Released board support package as listed on http://licensing.qnx.com/published/eula/x86rp1_00.html;
- (vi) "Software" means the specific version of the QNX Neutrino RTOS software that you can access on the enclosed CD, or from an image in the case of a download, based on the License Keys provided by QSS.

2. License Rights.

- (a) Grant of License. Subject to the terms and conditions of this Agreement, and any limitations imposed as part of a special beta test, promotional or educational program, QSS hereby grants to you a non-exclusive, personal, non-sublicensable, non-transferable license to use the Software on one computer. This includes reproducing the Software, but only as reasonably required to install and use it as intended in associated QSS user documentation on your licensed computer and to follow your normal back-up practices. All copies must bear all copyright and other proprietary rights notices that appear on the Software as originally provided by QSS. The license is conditional upon you having received the Software from QSS, an authorized QSS distributor or a validly licensed VAR, or in accordance with the assignment provisions below.
- (b) License Limitations. Subject to the license expressly granted above, you obtain no right, title, interest or other license in or to any Software, including but not limited to any copyright, patent, trade secret, trademark, or other proprietary rights therein. All whole and partial copies of the Software remain the property of QSS or its licensors and will be considered part of the Software for the purpose of this Agreement.
- (c) Use Restrictions. Unless expressly permitted by this Agreement, or otherwise by applicable law or by QSS in writing, you shall not:
 - (i) use, reproduce, modify, adapt, translate, update or transmit any Software, in whole or in part;

- (ii) use the Software for development purposes that normally require a QNX Momentics Development Suite and associated license, except that you are allowed to replace or append configuration files to enable the Software to work in your Environment;
- (iii) rent, lease, license, transfer, or otherwise provide access to any Software;
- (iv) disclose or provide access to your License Key(s) to another person or attempt or assist others to defeat Software locks or to use unauthorized License Keys;
- (v) alter, remove, or cover trademarks or proprietary notices in or on any Software;
- (vi) directly or indirectly, export, import or transmit the Software to any country in contravention of the laws of that country or the laws of Canada or the United States. Without restricting the foregoing, the Software may contain encryption capabilities and certain governments may regulate the export or import of the Software; or
- (vii) decompile, disassemble, decrypt, unbundle, extract or otherwise attempt or assist others to reverse engineer any Software, except as necessary, when permitted by an applicable law, to correct defects or achieve interoperability with complementary programs, for your purposes only, but only if QSS has refused to provide the necessary information or assistance.

Unless QSS has provided you with express written consent, the Software may not be used in any application in which a failure of the Software could lead to death, personal injury, or severe physical or property damage (collectively, "**High-Risk Applications**"), including but not limited to the operation of nuclear facilities, mass transit systems, aircraft navigation or aircraft communication systems, air traffic control, weapon systems, and direct life support machines. - (e) Tracing. QSS and its authorized representatives shall have the right to trace Software and License Key serial numbers at any time and in any reasonable manner.
- (f) Third Party Software. Parts of the Software may contain third party code. Such Software is sublicensed to you, when permitted, under the standard terms of this Agreement or may be licensed to you under amended or alternative terms. Those terms, and any Software authorship attribution and like notices that QSS is obliged to provide to you, are referenced in the License Guide and are published in the corresponding Third Party Open Source License Terms Guide, both of which can be found through <http://licensing.qnx.com/published/eula/index.html>. Unless expressly provided otherwise, all third party code is provided to you solely for use in association with the Software.
- (g) No Support. QSS does not provide any support for the Software in the form in which you have licensed it. In order to obtain support from QSS you must first purchase a QNX Momentics Development Suite license and associated support agreement; contact sales@qnx.com for details.

3. Limited Warranty

- (a) Background. QSS tests the Software on Reference Platforms. QSS DOES NOT WARRANT THAT ANY SOFTWARE WILL FUNCTION IN ACCORDANCE WITH RELATED DOCUMENTATION IN EVERY ENVIRONMENT. QSS IS UNAWARE OF THE ENVIRONMENT IN WHICH YOU INTEND TO USE THE SOFTWARE. QSS ACCEPTS NO RESPONSIBILITY FOR INTEGRATING THE SOFTWARE INTO AND/OR TESTING THE SOFTWARE TO ENSURE IT IS SUITABLE FOR YOUR ENVIRONMENT. SUCH TESTING IS EITHER YOUR RESPONSIBILITY OR THAT OF YOUR SOLUTION PROVIDER.
- (b) Warranty. QSS warrants to you for a period of 90 days from acceptance of this Agreement (as provided above) that each Software module as delivered by QSS is capable of performing the functions described in related QSS user documentation when used on Reference Platforms. QSS also warrants that any associated QSS media will be free from defects in material and workmanship under normal use for a period of 90 days from acceptance of this Agreement. QSS is not responsible for media defects that result from accident or abuse. Your sole remedy for any breach of warranty will be to either: (i) terminate this Agreement and receive a refund of any associated license fees paid to QSS; or (ii) to receive replacement media. QSS has no obligation under this Agreement to provide maintenance, support, or training.
- (c) WARRANTY DISCLAIMER. EXCEPT AS EXPRESSLY PROVIDED HEREIN, THE LICENSED SOFTWARE PRODUCTS AND ANY SERVICES PROVIDED UNDER THIS AGREEMENT ARE PROVIDED "AS IS" WITHOUT ANY WARRANTIES OF ANY KIND, INCLUDING IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON- INFRINGEMENT. IN NO EVENT WILL QSS OR ITS AFFILIATES, OR THEIR OFFICERS, EMPLOYEES, AGENTS, SUPPLIERS, DISTRIBUTORS, OR LICENSORS, (COLLECTIVELY, QSS AND ITS REPRESENTATIVES) BE LIABLE TO YOU, YOUR CONSULTANTS, OR ANY OTHER THIRD PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING BUT NOT LIMITED TO LOST REVENUE, LOST OR DAMAGED DATA, OR OTHER COMMERCIAL OR ECONOMIC LOSS, ARISING OUT OF OR RELATING TO ANY

These provisions are made expressly for the benefit of such licensors and are enforceable by them in addition to QSS. NEITHER QSS NOR ANY OF ITS REPRESENTATIVES MAKES OR PASSES ON TO YOU OR OTHER THIRD PARTIES, ANY WARRANTY OR REPRESENTATION ON BEHALF OF QSS'S LICENSORS.

5. Term.

- (a) This Agreement commences upon your acceptance (as described above) and will end when terminated. You may terminate this Agreement at any time. It will be deemed to terminate immediately if you fail to comply with any material term herein. Upon termination your license rights end and you shall immediately destroy all whole or partial copies of all Software and any associated License Keys in your possession or control.

6. General

- (a) Entire Agreement. This Agreement and any other terms expressly referenced by this Agreement constitutes the entire agreement between the parties pertaining to its subject matter and supercedes any prior or contemporaneous agreement, representation, statement, negotiation or undertaking dealing with the same subject matter. No amendment, modification or waiver of any part of this Agreement will be binding unless in a written document that expressly refers to this Agreement and that is signed by both parties. The terms and conditions of this Agreement will prevail over any inconsistent or additional terms or conditions of either party's purchase orders or invoices.
- (b) Assignment. Subject to the export restrictions above, you may assign this Agreement to a third party who has provided QSS with prior written acknowledgement of their acceptance of the terms of this Agreement. In such a case you must transfer your License Keys to the assignee and destroy all whole or partial copies of the Software and License Keys that are in your possession or control. Any other attempted assignment or delegation in violation of the foregoing will be void and of no effect. This Agreement will inure to the benefit of and be binding upon the parties and their respective successors and permitted assigns.
- (c) Governing Law. This Agreement will be governed by and construed in accordance with the laws in force in the Province of Ontario, Canada without regard to the conflicts of laws provisions thereof. The parties hereby irrevocably waive: (1) the provisions of the United Nations Convention on Contracts for the International Sale of Goods, and (2) any right to a trial by jury regarding the resolution of any dispute between the parties hereto arising out of or in connection with this Agreement. If any provision of this Agreement is held by a court of competent jurisdiction to be illegal, invalid, or unenforceable, the remaining provisions shall remain in full force and effect.
