Please refer to your license certificate to identify specific software product you have licensed. Depending on the version of the software product you have licensed, you will be able to locate the specific link to the development license that applies to you. (Please note that the relevant license will also be presented to you when you download a copy of the software.)

Where there are three licenses listed for a particular version of the software product, for example a "Commercial", "Partner" and "Non-commercial/Academic" versions of the license, then the applicable license will depend on the "Class" of license you purchased or otherwise obtained. The class of license you purchased is also identified in the license certificate issued to you. For example, if the license certificate issued to you identifies that you have purchased a license to Software Development Platform (SDP 7.1) and the class identified in your license certificate specifies that you have purchased a "Commercial License Class" license, then the license identified as the "Commercial" version of the license will apply to you. Similarly, if the license certificate issued to you identifies a "Partner License Class" then the license identified as the "Partner" version of the license will apply to you and if the license certificate issued to you identifies a "Non-Commercial/Academic License Class" then the license identified as the "Non-Commercial/Academic" version of the license will apply to you. Where there is only one license identified, then all license classes and types are covered by the license listed.

Certain distribution license agreements are also provided below under the heading "Production License Agreements – Current Products".
